Dear Department of Planning and Environment (DPE)

In line with Condition C9 of the Development Consent for the Western Sydney Green Gas Project (Application No: SSD 10313), an Independent Environment Audit was carried out in August 2025 and the audit report was issued by the Auditor on 26 August 2025.

A total of 4 non-conformances and 1 Opportunity for Improvement were identified during the audit. These are captured in the audit report.
