

## **Tariff Adjustment**

The annual tariff adjustment formula is:

$$T_r = T_b \times \left[ 1 + \left( \frac{CPI_r - CPI_b}{CPI_b} \right) \right]$$

Where:

 $T_r$ = relevant Service Charge, applicable from Review Date

 $T_b$ = relevant base Service Charge in base year

CPI = Consumer Price Index (All Groups weighted Average of Eight Capital Cities) published quarterly by the Australian Bureau of Statistics.

 $\mathit{CPI}_r$  = CPI published for the December quarter immediately before relevant Review Date

 $CPI_b$  = CPI published for the December quarter for the year prior to the base year 2020 Review Date = Annually, 1 January each year.
